## Project Summary

#### Project Description

Appalachian State University Campus Dining is prepared to move forward into a formal design project to implement an all-you-care-to-eat food service operation. A 2019 study identified the essential elements needed to consider in each of the four primary campus dining venues to stage and incrementally incorporate such an operation. The first phase will be geared toward access control, point-of-sale and minimal reconfiguration of fountain drink access and dish returns. A later phase, or phases, would seek to renovate existing areas to reset retailing and expand or modify areas for franchise opportunities and/or expand product availability and mealtimes. The project design will include all or part of four existing campus dining venues.

This project seeks to engage a designer to develop the strategic concepts of the study into a working design and budget.

Current project authorization is for advance planning only. The selected firm may be retained through full design and construction at the University's option.

#### Project Budget

The total authority for the Advanced Planning portion of the project is \$210,674.00 for a total estimated project of \$2,475,414.00.
